PART 2 – AFFILIATE MEMBERSHIP

- 2.0** Affiliate Membership is open to organization having an interest in ICIS. All applications for Affiliate Membership are subject to approval by the Board of Directors.
- 2.1** Every member shall uphold the Constitution and comply with the Bylaws of ICIS.
- 2.2** Persons mentioned in Bylaw 2.1 desiring membership in ICIS may, upon payment of a fee set annually by the Board of Directors, have membership in ICIS for the current fiscal year. If the applicant does not wish to access ICIS data, the annual fee will be \$0.
- 2.3** A person shall cease to be a member of ICIS:
- by the organization delivering a letter of resignation to the Secretary-Treasurer of ICIS or by mailing or delivering it to the address of ICIS;
 - on dissolution of the organization;
 - on being expelled; or
 - on having been a member not in good standing for 12 consecutive months.
- 2.4** Cancellation of Membership:
- A membership may be cancelled by a special resolution of the members passed at a General Meeting of ICIS.
 - The notice of special resolution for cancellation shall be accompanied by a brief statement of the reason(s) for the proposed cancellation.
 - The organization, who is the subject of the proposed resolution for membership, cancellation shall be given an opportunity to be heard at the General Meeting before the special resolution is put to a vote.
- 2.5** All members are in good standing except a member who has failed to pay his/her current annual membership fee (if applicable) or any other subscription or debt due and owing by him/her to ICIS and he/she is not in good standing so long as the debt remains unpaid.
- 2.6** Any Affiliate Member requiring the use of ICIS data or other product will be subject to an approval process and acceptance including the execution of ICIS' standard membership Data Sharing and Licence Agreement (DSLA) and associated data use fee structure.
